INTRODUCTION

This document provides information to assist you to import data into your implementation of ReliaSoft XFRACAS by HBM Prenscia. It describes the XML elements and attributes in the XML Document Type Definition (DTD) for each type of record you can import or export. It also describes the functions in the XFRACAS web service. DEFINITIONS

XML ELEMENT

Information unit within an XML document consisting of a start tag, an end tag, the value between the tags and any XML attributes.

Example: `<ExampleElement></ExampleElement>`

ATTRIBUTE

A combination of a name and a value that provides additional information about an XML element.

Example: `<ExampleElement exampleAttribute="1"></ExampleElement>`

VALUE

XML data located between a start tag and an end tag.

Example: `<ExampleElement>ExampleValue</ExampleElement>`

REQUIRED ELEMENTS

Highlighted elements are required.

Example: `<ExampleElement>`

COMMON ELEMENTS

EXPORT DATA

- The ExportData element contains information about the export.
- This will be present on all XML files exported from the XFRACAS user interface. **Nothing is imported from this element.**

RESOURCES

- The Resources element contains translations for supported interface languages. It is used for the XSLT-based “Print Preview” feature in the XFRACAS user interface.
- This will be present on most XML files exported from the XFRACAS user interface. **Nothing is imported from this element.**

VALID ENTITY

- The Entity element is required.
- The EntityID element value or the EntityName value must match an existing entity.
- The EntityID element is checked first and if no match is found the EntityName element is checked.

If neither value matches an existing entity, the import will be stopped.

VALID ISSUE

A valid Issue must meet the following requirements:

- The Issue element must contain an IssueTypeID attribute.
- The Issue element must contain a Description element.
- The Code element is optional.
- The Description element must have a value.

A combination of IssueType, Code and Description must match an existing issue. (Only description is required.)

VALID PART

A valid Part must meet the following requirements:

- The PartName or PartNumber element must be present.
- The PartName or PartNumber element must contain a value.

If the combination of PartName, PartNumber and PartVersion match an existing part, then it will be used. (Either PartName or PartNumber is required.)

VALID USER

- The FirstName, MiddleName, LastName and Login elements can be nested in any element.
- The Login element is required and its value must match an existing user's login.
- The login is typically a "DomainName\Username" but could also be an SSO ID if that is being used.

VALID DATE

- The Day, Month and Year must be a valid date.
- If the Hour, Minute or Second elements contain values, they must be a valid time.
- All Dates should be in UTC or GMT+0 (because all data stored in the database is in UTC).

FormattedDate is for display information on the export only.

IMPORT CONFIGURATION

The ImportConfiguration element is used to specify import settings and should be placed below the ExportData or Resources element if present and above the first import type element (Incident, Problem, etc). The Import Configurations are optional and if present must be “Yes” or “No” (empty is treated as no). The elements below are available on every import type. In addition, Incidents have additional elements specifically for that import.

XML Element	Description
<BatchInsert></BatchInsert>	Determines if the import queries are executed individually or in batches to improve performance. Each batch will contain approximately 1000 queries and by default will be executed in its own transaction. A query batch will contain all the queries to import a number of import types (incident, problem, system, etc). For very large imports with more

than 1000 queries per import type the batch will be split at 1000 queries and may not contain all the queries to import an import type.

Default value: “No.”

<SplitTransaction></SplitTransaction>

Determines if insert queries are run in one transaction or split into multiple transactions.

SplitTransaction settings:

Batch: Each batch of queries will run in its own transaction. This is the default value when BatchInsert is enabled, and is an invalid setting when BatchInsert is not enabled. This setting allows for any batch of queries to fail while still successfully importing the remaining batches. If this setting is enabled and if one type has a failure and another is imported successfully, the imported file and import log will appear in the Error section of the Data Import page.

Type: Each import type (incident, problem, etc) in the file will be run in its own transaction. Not available for batch inserts. This setting is useful when importing a large number of types without batch import enabled, as it prevents an error in one type from rolling back the entire import. If this setting is enabled and if one type has a failure and another is imported successfully, the imported file and import log will appear in the Error section of the Data Import page.

NoSplit: All queries will be run in one transaction even if BatchInsert is enabled or there are multiple import types in one file. This is the default value when BatchInsert is disabled. This setting allows for rolling back the entire import if an error occurs anywhere.

Yes: If BatchInsert is enabled, each batch will be inserted in its own transaction. This setting is invalid if BatchInsert is not enabled.

No: All queries will be run in one transaction, same as the NoSplit setting.

`<EnableUpdate></EnableUpdate>`

Sets whether the import can update existing records. Default value: “No.”

No: If the relevant ID matches an existing record, the record will not be imported and it will be logged as a duplicate in the error log.

Yes: If the relevant ID matches an existing record, certain fields can be updated.

This applies only for incident records. For information on the fields that can be updated, see Incident Import Configuration, Incident Elements and Update Details.

`<UpdateOnly></UpdateOnly>`

Sets whether the import can insert new values when updating an existing record. Default value: “No.”

No: The import can modify/delete existing values or add new values.

Yes: The import can modify/delete existing values, but it will not add new values if the field was previously blank.

This applies only for incident records and only if EnableUpdate is “Yes.” For information on how this applies for the fields that can be updated, see Incident Import Configuration, Incident Elements and Update Details.

`<InsertDetailIssues></InsertDetailIssues>`

Sets whether details containing issues can use only existing issues or if new issues can be inserted if existing ones are not found. Default value: “No.”

INCIDENTS

INCIDENT IMPORT CONFIGURATION

The following elements are Incident-specific import settings that may be present below the standard ImportConfiguration elements (see Import Configuration section).

<code><UpdateASPFieldServiceTech></UpdateASPFieldServiceTech></code>	Determines if the ASP Field Service Tech can be updated if EnableUpdate is set to "Yes." Default value: "Yes."

<code><UpdateSystemStatuses></UpdateSystemStatuses></code>	Determines if System Statuses can be updated if EnableUpdate is set to "Yes." Default value: "Yes."
<code><UpdateTeamMembers></UpdateTeamMembers></code>	Determines if Team Members can be updated if EnableUpdate is set to "Yes." Default value: "Yes."
<code><UpdateReportedRunHours></UpdateReportedRunHours></code>	Determines if Reported Run Hours can be updated if EnableUpdate is set to "Yes." Default value: "Yes."
<code><UpdateActions></UpdateActions></code>	Determines if Actions can be updated if EnableUpdate is set to "Yes." Default value: "Yes."
<code><UpdateDetails></UpdateDetails></code>	Determines if Details can be updated if EnableUpdate is set to "Yes." Default value: "Yes."
<code><SendIncidentEmail><SendIncidentEmail></code>	Determines if e-mails can be sent when the import creates new incidents. Default value: "No."

Yes: If the “E-mail – Incident Creation” preference in XFRACAS is true, e-mails will be sent to the incident owners (i.e., the same as for new incidents created via the website).

No: Regardless of the preference in XFRACAS, e-mails will not be sent for new incidents created via import.

If SendIncidentEmail is set to “Yes,” sets additional recipients for e-mails that are generated when the import creates new incidents. This is optional. If specified, it can be a single e-mail address or multiple addresses separated by commas (e.g., “cc1@domain.com, cc2@domain.com”).

INCIDENT ELEMENTS

The following table describes the behavior for importing a new record or, when applicable, updating certain fields in an existing record.

The update behavior applies if a) EnableUpdate is “Yes,” b) the import configuration element for the relevant field is “Yes” (e.g., UpdateCreator, UpdateOwner, UpdateDetails, etc.) and c) the IncidentID matches an existing record.

<p><IncidentID /></p>	<p>The IncidentID element is required but the value is not.</p> <p>If the element is empty, the next available incident ID for that entity will be used for the new record.</p> <p>If the element has a value that does not match an existing incident ID, the specified value will be used for the new record.</p> <p>If the element has a value that matches an existing ID, the behavior depends on EnableUpdate. If “No,” it will be logged as a duplicate in the error log and a new record will not be imported. If “Yes,” certain fields in the existing record may be updated.</p>
<p><Title /></p>	<p>The Title (String) element is optional. Maximum of 100 characters allowed.</p> <p>Update: The title will be updated if it does not match the original title.</p>
<p><Entity> <EntityID /> <EntityName /> </Entity></p>	<p>The Entity element is required and it must contain a valid entity.</p> <p>If the Entity is not valid, the incident will not be imported.</p> <p>Update: Not updateable.</p>

The ASPFieldServiceTech element is optional. If present, the combination of FirstName, LastName and Email element values must match an existing customer. The FirstName and LastName elements are required.

Update: The ASP Field Service Tech will be updated if the the ASP Field Service Tech customer matches an existing customer and differs from the original ASP Field Service Tech. If the UpdateOnly setting is enabled and if no original ASP Field Service Tech is found, one cannot be added.

XFRACAS WEB SERVICE

The following functions are available in the XFRACAS web service. For more information, including an example project, please consult the XFRACAS admin help.

PERMISSIONS

Calling the web service requires passing Windows credentials that are used to check permissions in XFRACAS. The user that your application runs as must have the “Access Admin Tab” and “Manage Import” permissions for the relevant entities in XFRACAS. For functions with an entity ID parameter (eid), the permissions are checked on that entity. Otherwise, the permissions are checked against the user’s default entity.

BASE URL

If the URL to XFRACAS is `http://myhost/xfracas`, the base URL for the web service will be `http://myhost/xfracas/xfapi/`.

FUNCTIONS

Each of the service functions is called by hitting a URL, either with a form POST, or a GET request. Note that all of the parameters must be URL-escaped. For example, the filename parameter would be “my+file.xml” for a file named “my file.xml”.

Note that date parameters are transcoded via .NET and must be UTC dates formatted per ISO 8601. For example: 2017-12-01T18:00:00. Dates inside Strings in some of the response examples below may be in other formats.

Parameters marked with * are required. Parameters marked with ** are a group of parameters, one of which is required (for example, one of m1, m2 or m3 is required for the importmetrics function).

importxml – Inserts an XML file (which may contain data for one or multiple records) into the XFRACAS import queue. This is equivalent to clicking **Add** on the XFRACAS Data Import page. Uploads an XML byte array and returns a UUID that identifies the file that was added to the queue (the import record id).

Note: The maximum size for files that can be inserted into the queue by the web service is set via the XFRACAS Admin utility on the web server.
